IN EXERCISE of the powers contained in section thirty-seven of e Standards Act, the following Regulations are hereby made:

- 1. These Regulations may be cited as the Standards Title Compulsory Standards) (Fees) Regulations, 2012.
- 2. The fees set out in the Schedule are payable by an importer manufacturer of a product to which a compulsory standard plies.
